

JOB DESCRIPTION YOUNG PEOPLE'S WORKER Young People Affected by Family Substance Use

Number of Hours: Part-time (18 hours per week)

Salary Scale: Pro-rata £28,506 - £33,041 per annum (SCP 12 - 17)

Accountability of post: The post holder will be line managed by and accountable to

Circle's Project Manager for the performance of the tasks

described below.

Main purpose: To reduce the impact of substance use on young people by

offering strengths-based and co-produced one-to-one, peer, advocacy and group work in youth and community settings. It is expected that the post holder will do occasional weekend and

some evening work.

Location of post: Prestonpans Community Centre (Hybrid working applicable; own

car and driving licence essential.)

MAIN TASKS & RESPONSIBILITIES:

- 1. To identify, engage and work alongside young people affected by family substance use, providing them with a co-developed programme of support
- 2. To work with young people on a one-to-one basis as appropriate, addressing specific issues relating to substance use in their families, providing advice and guidance, and signposting and referring onto other agencies as required
- 3. To support young people to develop coping skills, resilience, and strategies to reduce the negative impact of substance use
- 4. To support young people's emotional development, helping them to increase their self-esteem, including helping young people to identify and build on their strengths
- 5. To facilitate opportunities for young people to come together including through 'safe space' peer groups and whole family activities
- 6. To actively promote family recovery and family inclusive practice, including working to an evidence base e.g., CRAFT, and developing new resources
- 7. To deliver training and share the work of the project with other professionals as per the partnership Memorandum of Understanding expectations or good practice
- 8. To record, monitor and evaluate all work
- 9. To attend supervision, team meetings and training as appropriate
- 10. To contribute to the promotion and development of the Grow Your Own Routes programme and Circle's work and services in East Lothian
- 11. To work within Circle's policies and procedures, most notably in areas of child protection, equal opportunities, anti-discriminatory practice, and user participation
- 12. To attend Staff Development Days and Scottish Families external events

This job description is not exhaustive and may be amended in response to organisational needs. The postholder is expected to undertake any other duties appropriate to the level and nature of the post.
